## **BOARD ELECTION 2023**

- 1. The Board is elected under the triennial rule whereby a third of the Board is elected each year for a three (3) year term on a rotating basis.
- 2. Two (2) directors will be elected this year for a three (3) year term of office. In order to be eligible to be nominated for, elected to and remain in office on the Board, directors nominating for one of the three positions must each have the qualification of:
  - (i) being a Life member or a financial Club member, whose ordinary place of residence is not more than a 200 kilometre radius from the Club's premises at Cammeray;
- 3. Due to a casual vacancy arising on the Board during the past year, one (1) director will be elected this year for a one (1) year term of office
- 4. Nomination forms have been made available for download from the Legal and Governance tab within the Norths Collective website or available to be obtained from reception at Norths Cammeray or Seagulls Club from midday on Wednesday 19th April 2023.
- 5. Nominations will close at 5:00pm on Tuesday 2nd May 2023 and all nomination forms must be returned to the Club before that time.

- 6. A nominee for election to the Board must have been a member of the Club for a continuous period of three (3) years immediately prior to the date of their nomination.
- 7. If by the close of nominations, the number of nominations exceeds the number of positions to be elected to the Board, then a ballot (vote) to determine the successful candidates will be necessary.
- 8. The draw for the order of the candidates on the ballot paper will be conducted by the Returning Officer at 6:00pm on Wednesday 3rd May 2023 in the Club's reception area near the main lounge at Norths Cammeray.
- 9. Candidates may be present to observe the draw for ballot position in the presence of the Returning Officer.
- 10. The ballot (voting) commences on Monday 15th May 2023 and finishes on Sunday 21st May 2023 between the hours of 12 noon to 8pm daily at Norths Cammeray and Seagulls Club Tweed Heads.
