

# **Terms and Conditions – Norths Collective**

## **\$0 Norths Collective Groupwide membership promotion**

**October 31 2024 – January 31 2025**

### ***Promotional Period***

1. The \$0 Norths Collective membership promotion commences on Thursday 31 October 2024 and concludes Friday 31 January 2025.

### ***Entry Requirements***

2. All new members joining Norths Collective either online or in-person in any venue is eligible to receive a one-year membership for \$0.
3. All existing members with a membership expiry date from 1/11/24 – 31/1/25 will receive a \$0 one-year renewal on their membership.
4. Members joining online will still need to enter the venue and show their photo identification at a venue's reception desk for their membership to be finalised.
5. Members joining in venue can do so at any Circlescan terminal by simply scanning their photo identification, entering an email address, mobile phone number and occupation then submitting this. Once submitted their membership will be active
6. In the event the Circlescan system is down a digital form can be accessed in venue to join Norths Collective for \$0 using this form.
7. Unfinancial members who expired after 31/12/2018 can renew their membership for \$0 for a year using the renewal form and are not able to re-join.
8. Unfinancial members who expired before 31/12/2018 will need to re-join for \$0 for a year using the join methods outlined above.
9. Members who renew for \$0 during the promotional period will not receive the renewal bonus collective points unless they are in Diamond, Platinum, Gold or Silver tiers who will still receive their collective renewal points.

## **General**

10. Norths Collective reserves the right to cancel or change the prizes offered under this promotion if there are any changes to the law which would render the promotion or any prizes offered under the promotion unlawful.
